NEW	Additional Canadian Tweaks. Has Canadian Addressing tweaks which allow for non-US zip codes and Provinces and Terriotries are now incorporated. Now records properly	2.8.14. 32
NEW	BluePrince Client installer now needs to be installed to C:\CityView\BluePrince. This will allow BluePrince to work correctly on the latest version of Windows. BluePrince needs to access a local BluePrince.ini file to set the display settings and connect to the database. The old install directory of Program Files and Program Files (x86) on the latest version of Windows will not allow software to explicitly call a local ini file without elevated privileges. This was causing the software to be run as Administrator more often than not if the user account on the domain was not given more rights / admin rights. Some customers do not allow for this kind of access so installing in a different directory allows the software to call it's local configuration file without running as administrator. This is now Default with the installer	2.8.14.
